EXAMINATION

BY MR. ODENEAL:

Q. Dr. Georgulas, have you seen the emails that Ms. Swanson sent to Jeff?

A. Yes.

Q. And isn't it true that she used the name  
James --

Yes.

Q. -- in his emails? And in all the court papers, his legal name is James?

A. Correct.

Q. And on his birth certificate, his legal name  
is James?

A. Correct.

Q. But you're asking the court to order him to  
deny that? Is that true?

A. I'm not -- I think -- I am not asking the  
court to order him to deny that. I'm asking the court  
to order him to respect his child's choices of using her  
preferred name.

Q. So isn't it true that biologically James is a  
boy?

A. Yes.

Q. And so you're asking the court to order Mr.  
Younger to not affirm that that's his son when he goes to school?

A. Correct.

Q. And that he doesn't have twin boys; is that  
right?

A. Yes.

Q. And you don't want him to be able to talk to  
anyone at the school, anyone related to the school,  
parents; is that right?

At least not in the school setting, yes.

Q. You don't want him to be able to talk to any  
teachers?

A. No, he can talk to the teachers. We just --  
we have just discussed that. We just --

Q. Administrators?

A. Yes.

Q. He can talk to the administrators?

Q. But you don't want him to -- him to be able to say my son James?

A. If he says that in the -- in a closed setting, where the administrators know, the teachers know, but the parents don't know. Some of them suspect probably because of the very short hair, but probably -- as far as I know, only two or three parents know for sure that Luna was assigned male at birth. But the other ones, you know, some of them suspect. They don't know. And a lot of people don't even suspect. And I know that because of interactions I've had with the parents that it's been very clear to me that they don't suspect that my child is anything but how she presents. And that is a beautiful thing. That is an affirming, good for her psychology, it's good for her. Being outed can be very harmful to her.
